Dr Emil Dardak, EAROPH President

Emil is an Indonesian politician who was Vice Governor of West Java. He was appointed EAROPH President in 2022. His tenure ends at the EAROPH Congress in Islamabad in

December 2024.



Kate Raworth, Doughnut Economics Action Lab (DEAL)

Kate Raworth (sounds like 'Ray-worth') is a renegade economist focused on making economics fit for 21st century realities. She is the creator of the Doughnut of social and planetary boundaries, and co-founder of Doughnut Economics Action Lab. Her internationally best-selling book *Doughnut Economics: seven ways to think like a 21st century economist* has been translated into over 20 languages and has been widely influential with diverse audiences, from the UN General Assembly to Pope Francis to Extinction Rebellion. Kate is a Senior Associate at Oxford University's Environmental Change Institute, and is also Professor of Practice at Amsterdam University of Applied Sciences.



Omar Siddique, Lead, SDG Localisation and City Climate Action, Sustainable Urban Development Section, UNESCAP

Omar Siddique is an urbanist and development planner with 20 years' experience in more than 40 countries in the planning, management and evaluation of complex programmes in urban contexts. His work focuses on spatial planning, housing, land, infrastructure, transportation, employment and environmental conundrums during rapid urbanisation. He holds advanced degrees and certifications in urban planning, political science and geography from New York University and Monash University, Australia.



Steve Gawler, Local Governments for Sustainability (ICLEI)

Steve is Director International Programs for ICLEI Oceania. He joined ICLEI in 2008 as Director International Programs and was based in Jakarta for 7

years coordinating climate change and disaster risk reduction programs with cities in Indonesia and other parts of Asia. In 2015 Steve returned to Australia to take up the position of Regional Director. He has worked extensively in Solomon Islands, Fiji, Kiribati and other Pacific SIDS supporting sustainable urban development, climate change and disaster resilience building.

Sandi is a Kalkadoon/Kalkatungu, Ngawun, Yirandali woman from North-West Queensland. She is an experienced community development with a 35-year career working with Aboriginal and Torres Strait Islander communities across Queensland.
